Monthly storage fees are due on the 1st day of the month. A card on file will be charged on the 1st of every month that your unit is in storage. If your first month falls after the first, or you take your unit out of storage than you will be charged a pro-rated fee.

Picking up your unit:

You shall have access to your unit during normal operating hours for the sole purpose of dropping off or picking up. A 24 hour notice must be given when taking your RV out of storage or renting an RV site. Please make the office aware ASAP if you will no longer store your unit so you will not incur any other charges.

If you are lending your RV to another party other than yourself, YOU will need to inform the office before the other party makes the reservation.

Storage Rules

The following Rules and Regulations apply to Occupant's use of and activities within the Property. Coastline RV Resort reserves the right to adopt reasonable modifications and additions to these Rules and Regulations at any time. In the event of any conflict between these Rules and Regulations and the Agreement, the terms of the Agreement shall control.

- Storage area is locked 24/7. You may have access to your unit during business hours ONLY. You must notify front office to make arrangements and be accompanied by a host to access your unit.
- Only vehicles, boats and trailers in good working order are permitted in our storage area. You are responsible for disconnecting batteries, draining tanks, and making sure your unit is properly ready to be moved or stored. Coastline RV Resort is not held liable if something does not work properly on your unit. Each unit is inspected before and after a move and if there is something wrong with your unit you will be contacted by our office to schedule repairs or pick up.
- No Maintenance or Repair Work on site! Occupant acknowledges that the space is for his or her RV, vehicle or boat and is for storage purposes only; Occupant shall perform no maintenance or repair work on the property or anywhere within the Storage Area.
- Occupant is responsible for securing its RV, Vehicle or Boat with locks and security devices as necessary to protect it from theft or break-in. Coastline RV Resort does not maintain a security patrol on-site and does not guarantee the security of any Property stored in the Storage Area. Coastline RV Resort is not responsible for injury, damage, loss, or claims for damage to Property stored at the Storage Area due to theft, fire or other natural hazard, or any other causes. IT IS THE RESPONSIBILITY AND OBLIGATION OF EACH HOMEOWNER TO CARRY ANY INSURANCE AND HAVE A CURRENT REGISTRATION (current tag on the vehicle).
- It is the occupants responsibility to inform our office if any contact information has changed or needs to be updated. This insures that we are able to contact you encase of an emergency. Under tropical conditions please make arrangements 48 hrs before storm approach to either secure your unit better or take unit out of storage. Once our park is under evacuation orders you can not access our property. Coastline RV Resort takes no responsibility for any damaged incurred by mother nature.
